This position is permanent, full time (37.5hrs per week). Based at Brunton Park and includes working Saturdays and some evenings.

Main roles and responsibilities –

- Assisting with the delivery of the Professional Development Phase training and games programme (Youth team fixtures).
- Implement the existing Academy Performance plan to include the philosophy and vision of the Academy.
- Ensure Kitman Labs Application is up to date- training, games & reviews.
- Ensuring the Club EPPP administration requirements are met at all times.
- Identifying and developing the best 16-18 year old players for the Club.
- Attending and playing an active role in Academy Management meetings.
- Assist with the provision of exit strategies for those players not receiving professional contracts.
- Assist with the coaching and mentoring of players in the YD phase (U15/16 levels).
- Maintain appropriate levels of individual CPD.
- Work towards own Development Action Plan (DAP) agreed between you and the Head of Coaching in line with the CCF.
- Keeping up to date with EFL, FA and EPPP guidance and correspondence
